Lily didn't want to disappoint Tyla and wanted to make sure Tyla had another Big Sister in her life. After Lily's friend Kate heard the news, she stepped right in to be Tyla's new Big Sister. When Tyla first became a Little Sister in our program, she never imagined that she would gain two Big Sisters.

Since the day Kate and Tyla were first matched, there has never been a dull moment. Over the three years since they've been matched, they have tried a variety of activities together from making their own sushi rolls to taking pottery classes.



They also spent time exploring Tyla's opportunities after high school, with college being the next big thing on her mind. Tyla enjoyed that she was able to talk about college with her Big Sister Kate. After getting accepted into multiple universities, Tyla decided to attend Tuskegee University in Alabama after graduating from Madison East High School. While attending Tuskegee University, she plans to major in Chemistry and minor in Psychology and Business.

In 2017, we began to implement our strategic plan that called for investment into our infrastructure and capacity, since every year we are faced with 250 to 300 children who are still waiting to be introduced to a mentor. 


